In consideration of the extension of credit to Applicant, Applicant understands and agrees that the billings of PIEDMONT TRUCK TIRES, INC. are due and payable on the first 10th net prox. (Except when other terms are clearly stated on the invoice, then these special terms shall apply.) In the event an invoice is not paid within the terms stated on the invoice the open account is in default and is subject to an interest, late or service charge in the amount of 1.5% per month (18% per annum) on all outstanding principal balance past due. In the event Applicant defaults in payment or breaches any of its obligations to or agreements with PIEDMONT TRUCK TIRES, INC. Applicant agrees to pay all costs of collection, as well as all interest and finance charges accruing both before and after the entry of any judgement until paid, and reasonable attorneys' fees in the event PIEDMONT TRUCK TIRES, INC. is forced to seek legal counsel to enforce collection of Applicant's obligation and agreements.

In the event Applicant disputes or has any complaint about their open account with PIEDMONT TRUCK TIRES, INC. he/she should submit the complaint or dispute in writing so that it can be satisfactorily resolved.
